RETT'S ROOST'S SIGNATURE PROGRAM IS ITS FREE HEALING RETREATS FOR FAMILIES WHO ARE FACING CHILDHOOD CANCER OR CHILD LOSS. THE RETREATS GIVE FAMILIES MUCH NEEDED THERAPEUTIC AND PEER SUPPORT IN AN INTIMATE, NATURAL SETTING FOR 3-5 DAYS. IN 2025, WE HELD 6 RETREATS FOR 33 FAMILIES AND 3 COMMUNITY GATHERINGS FOR 48 CHILDREN AND 57 PARENTS (DAY EVENTS THAT BRING OUR FAMILIES TOGETHER). WE SENT OUT BIRTHDAY CARE PACKAGES TO 88 CHILDREN AND REMEMBRANCE GIFTS TO 52 BEREAVED FAMILIES. OVERALL WE OFFERED 33 FAMILIES (15 CHILDREN WITH CANCER, 15 SIBLINGS OF A CHILD WITH CANCER, 27 BEREAVED SIBLINGS, AND 68 PARENTS) WITH A RETREAT TRIP WORTH \$500-750 PER INDIVIDUAL.
